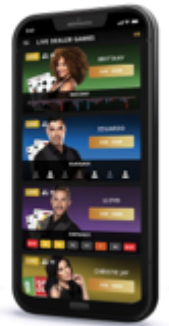

### **Proposed Shares for Debt Update**

VANCOUVER, British Columbia – April 29, 2024 – [Playgon Games Inc. \(TSX-V: DEAL / OTC PINK: PLGNF/ Frankfurt: 7CR\)](#) (“Playgon” or the “Company”), a propriety SaaS technology company delivering ‘state of the art’ mobile live dealer technology and eTable games to online gaming operators globally announces that, further to its previous press release dated April 8, 2024, the Company intends to settle an aggregate of \$127,036.67 of debt, representing interest payments owed to the holders of previously issued convertible unsecured debentures (the “Debentures”), via the proposed issuance of 4,234,553 common shares of Playgon (“Common Shares”) at a deemed issuance price of \$0.03 per Common Share (calculated based on the applicable VWAP as contemplated under the Indenture (as defined below)). Contrary to the previous press release, the Common Shares are being issued at a price of \$0.03 per Common Share pursuant to the VWAP calculation as contemplated under the applicable Indenture and as permitted pursuant to the rules and policies of the TSXV (as defined below).

The proposed issuance includes an aggregate issuance of approximately 4,042,887 Common Shares (reflecting the settlement of \$121,286.68 in interest payment debt) to insiders of Playgon who participated in the financing. As previously disclosed, the Debentures were issued by Playgon on December 29, 2023 pursuant to a debenture indenture dated January 19, 2023 (as supplemented by a second supplemental indenture dated December 29, 2023) (the “Indenture”) among Playgon and Odyssey Trust Company, as trustee (the “Trustee”). Pursuant to the terms of the Indenture, Playgon is authorized, at its discretion, to satisfy any portion of interest payments owed by way of the issuance of Common Shares by providing notice to the Trustee. The proposed shares for debt transaction is subject to the terms and conditions set forth in the policies of the TSX Venture Exchange (“TSXV”) and the completion of the shares for debt transaction, as well as the issuance of the Common Shares, remains subject to the review and approval of the TSXV.

The portion of the transaction involving the related party constitutes a “related party transaction” pursuant to Multilateral Instrument 61-101 (“MI 61-101”) and TSXV Policy 5.9. The Company is exempt from the formal valuation and minority shareholder approval requirements of MI 61-101 as neither the fair market value of the subject matter of, nor the fair market value of the consideration for, the transaction, insofar as it involves interested parties, exceeds 25% of the Company’s market capitalization.
