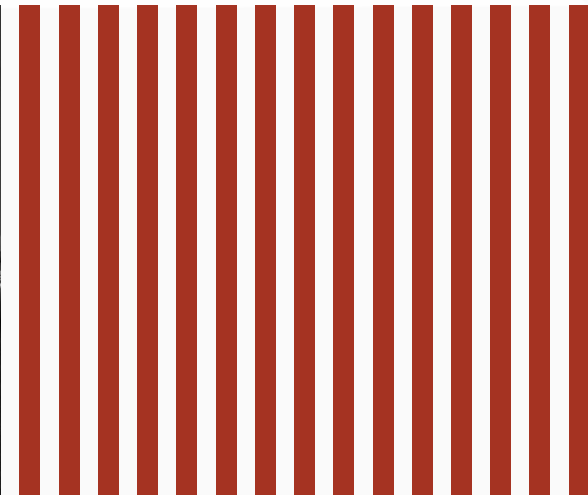

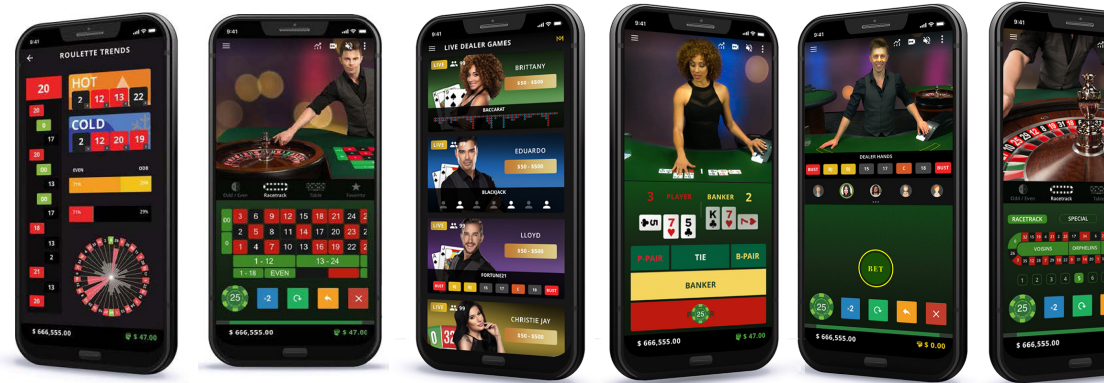

Global changes its name to Playgon Games Inc

AUGUST

Playgon changes TSX listing symbol to DEAL. Added new CFO and all operational staff for the Vegas studio

SEPTEMBER

Added new COO, Steve Baker and soft launched studio for client demo's

OCTOBER

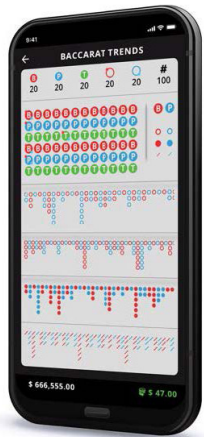
Entered into commercial agreement with IGL and made the decision to expand the studio capability to 25 tables from 15

NOVEMBER

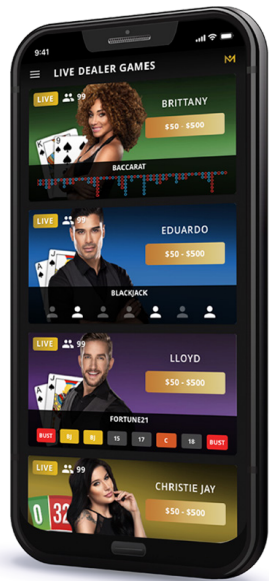
Started trading in the US on the OTCQB exchange and announced the competition and launch of our proprietary Tiger Bonus Baccarat

2021 HIGHLIGHTS



FEBRUARY

We complete the studio expansion to 25 tables

MARCH

We receive our class 1 Malta Gaming license and hire DuaneMorris LLP to start US licensing process

MAY

We officially production launch our Vegas Lounge studio in Las Vegas in South African and Malta with IGL and Swintt. We signed commercial deal with Solid Gaming the B2B division of London listed Gamesys Group

JUNE

Seven operators up and generating revenue through Swintt and IGL and room liquidity begins to build

AUGUST

We onboard seven additional operators through aggregators for a total of 14 operators live.

SEPTEMBER

We officially launch Solid Gaming and onboard an additional 6 operators through 4 aggregators. This now takes our live operator accounts to 20

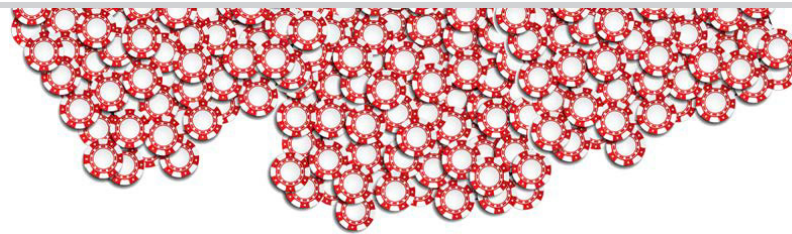


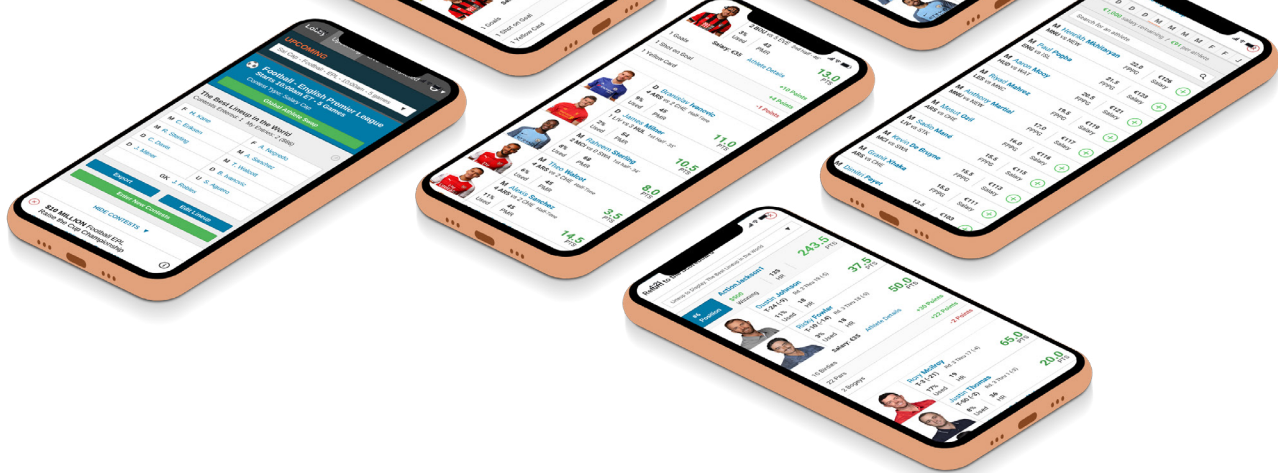
THE FUTURE OF DIGITAL CONVERGENCE
